COMMON ENTRY REQUIREMENTS

Please check your passports timely. All visitors from abroad must be in possession of a passport, which **must be valid for at least 6 months after the end of your journey** and there must be at least four blank pages in the passport. Passports for children must have a photo when the child is three years or older (please read more about special entry regulations for minors below and to the right).

Citizens from many countries may enter Namiba without a visa for a period of less than 90 days per year per tourist visa for tourist purposes only. The Visitors Entry Permit (a stamp with departure date and badge in the passport) will be granted on arrival at all official border posts upon presentation of a return ticket. In general, the permit is limited to the travel period as evidenced by the flight ticket.

For tourist from nations listed below, no special visa is required (source: Embassy of the Republic of Namibia, Berlin) as at date: Angola, Armenia, Australia, Austria, Azerbaijan, Belarus, Belgium, Botswana, Brazil, Canada, Cuba, Denmark, Finland, France, Georgia, Germany, Iceland, Ireland, Italy, Japan, Kazakhstan, Kenya, Kyrgyzstan, Lesotho, Lichtenstein, Luxemburg, Malaysia, Macau, Malawi, Moldova, Mozambique, New Zeeland, Netherlands, Norway, Portugal, Russia, South Africa, Singapore, Spain, Swaziland, Sweden, Switzerland, Tajikistan, Tanzania, Ukraine, United Kingdom, United States of America, Uzbekistan, Zambia, Zimbabwe. Tourists from other origins should contact the embassy as a visa must be obtained prior to travelling.

ENTRY WITH MINOR CHILDREN

All minors travelling through Namibia, Botswana and/or South Africa borders will be required to produce certified copies of unabridged birth certificates in addition to their valid passports. In the event that one parent is not travelling with the child, the other parent's affidavit consenting to such travel should be available. However, an affidavit will not be required if the father's name does not appear on the child's birth certificate (please see above).

Please take care that all documents are readable, neat and orderly without bends or cracks. Credentials do not need to be certified through a Notary. Certifications through a munipical community is sufficient.

Minors younger than 18 years traveling to Namibia must have an unabridged birth certificate. In addition, when travelling:

A. With an adult who is not their biological parent: an affidavit from their parents giving consent for the minor to travel with the adult is required.

B. With an adult other than a parent/legal guardian: copies of their legal guardians/parents' passports or documents of identity are required. Contact details of the parents/legal guardians should also be provided.

C. With a parent: an affidavit from the other parent giving consent for the minor to travel is required. A death certificate should be provided if one parent is deceased.

D. Unaccompanied: an affidavit from their parents/legal guardians consenting their travel, a letter containing the contact details and residential information of the person who will receive the minor passenger, a copy of the identity document, valid passport or permanent residence permit of the person who will receive the minor passenger, and thecontact details of the minor's parents/legal guardians are required.
